New Business:**Kile Allen:**

It was decided to have them come at the next council meeting starting at 6 pm. Jenni will get that set up with CIAW.

TIB Grant:

Mayor Weber read a letter from TIB that awarded the town \$90,000 to chip seal several streets in town. Mayor Weber signed the paperwork. Jenni will send it back to TIB tomorrow.
