Mayor Weber said that he would like to see a proposed plan from the Legion. He also suggested that the park maybe should be deeded to the town, since the town will be maintaining it. Dot will talk with the Legion about this.

Spot Sealing Letter:

Mayor Weber signed a letter asking the county to help with spot sealing this spring/summer.

Fountain Flying Letter:

Mayor Weber signed a letter allowing Fountain Flying to fly over Colton.

Whitman County Recycling:

Dot Sharp told the council that she spoke with David Nails and he has ordered three bins and is still waiting to get them.

SWEDA Bill:

The council approved to pay the SWEDA \$100 membership, with a motion from Sam Keller and a second from Ken Darby. It was carried by voice and passed by all.
