Jenni told the council that usually the town still charges for sewer because it is hooked up to the town's sewer line, but the council could make an exception due to the circumstances. Scott Miller motioned to waive the Ferro's sewer bill. Cory Cucchiara seconded the motion. The vote was carried by voice and passed by all.
