Steve Bremer:

Sewer Backed Up:

Steve told the council that when the power went out, it caused the sewer to get backed up. The PLC went out and it caused the sewer to get backed up for about an hour. He pumped out over 10K gallons. He is going to get a surge protector to ensure that this doesn't happen again.

Art and Greg Schultheis:

The Schultheis's presented cost totals of all of the revenue that the town incurred because of the subdivision that they put in over the last 20 years and said that they increased the town's valuation by \$6.3 million. They discussed the water rights that they helped the town attain and said that if they are not used, they could be confiscated. They again asked the Town Council to approve to pay \$20K to do the water capacity study, to see if the town has more than the current 215 water connections. They would like to sell their 11 acres to a developer to help the town continue to grow, but they cannot without ensuring that the town has more water connections available. They are also concerned about the school enrollment and said that if the school gets shut down that everyone's property value will plummet. After a long discussion the Schultheis's and the council all agreed that the sewer project is the priority at this time.
