**New Business:****Public Hearing, 2026 Budget:**

Steve asked the council if they wanted the street sweeper to pick up all of the leaves. The council agreed that the sweeper should be scheduled.

**WSDOT Letter:**

Mayor Weber read a letter from WSDOT requesting that the town be responsible for all of the maintenance on the RRFB's. Cory Cucchiara motioned to approve that the town will maintain the RRFB's and Ken Darby seconded the motion. The vote was carried by voice and passed by all.

**Sewer Project Update:**

Mayor Weber reminded everyone that the rebid opening will be on November 13<sup>th</sup> at 2 pm and that there will be a link to watch it.

**2026 Budget:**

Sam Keller motioned to approve the 2026 Budget. Scott Miller seconded the motion. The vote was carried by voice and passed by all.

**Legion Park Flag:**

Dot Sharp told the council that the Legion will still purchase the flags for the park. She is concerned about how difficult it is to raise it. Steve will look into this.
